## HERMOSA BEACH FRIENDS OF THE LIBRARY

ONE: The name of this corporation is HERMOSA BEACH FRIENDS OF THE LIBRARY.

TWO: This corporation is a non-profit public benefit corporation and is not organized for the private gain of any person. It is organized under the Non Profit Benefit Corporation Law for charitable purposes. The specific purposes for which this corporation is organized are to provide financial and charitable assistance to the City of Hermosa Beach Public Library by means of raising funds to donate to the said Library for the purchase of books, magazines and records for use by the general public, as well as providing other assistance to the said Library in the furtherance of its programs.

THREE: The name and address in the State of California of this corporation's initial agent for service of process is Clyde W. Malone, Jr., 260 - 31st Street, Hermosa Beach, California, 90254.

FOUR: (a) This corporation is organized and operated exclusively for charitable and literary purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

(b) Not withstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

(c) No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign, including the publishing or distribution of statements on behalf of any candidate for public office.
